## The general concept of official statistics

- √ "Statistics", data required for production of organized statistical information, obtained from censuses and statistical surveys or administrative records;
- √ "Statistical Information", any organized quantitative and/or qualitative information obtained from statistical data that facilitates understanding of economic, political, demographic, social, environmental and cultural trends, and of gender and governance etc-related issues

#### Official Statistics in Africa

- According to Jean Ping Chairperson of the African Union Commission, Statistical information has become a vital and indispensable tool in the regional and continental integration process
- For the moment, quality statistical data produced by the African statistical system is virtually inexistent.
- To remedy this shortfall, the decision-making organs of the African Union took the historic step to call for the elaboration of an African Charter on Statistics, which will serve not only as a legal instrument to regulate statistical activity but also as a tool for advocacy and the development of statistics in Africa.

#### **National Statistical System**

The national statistical system (NSS) is the ensemble of statistical organizations and units within a country that jointly collect, process and disseminate official statistics on behalf of national government.

☐ The national Statistical system (NSS) comprises of data Producers, Users, Suppliers and Research & Training Institutions.

- Production must follow the following process





National statistics offices in African countries should endeavour to develop strong partnerships with academics to raise statistical capability to enhance quality of work from both users and producers of official statistics

African countries should constantly emphasise on formation of policies that enhance accessibility of official statistics

National statistics offices in Africa should endeavor to constantly organize workshops/conferences on methodological standards guiding both production and usage of official statistics

National statistics institutions in Africa should endeavor to establish a network of academics in official statistics whose members will be involved in the design, implementation, delivery and assessment of professional courses for both the users and producers of official statistics



#### **Future Directions**

- One common point for all the users is their need to be able to trust the official information. They need to be confident that the results published are authoritative and unbiased. Producers of official statistics must maintain a reputation of professionalism and independence
  - The statistical system in Africa must be free from interference that could influence their decisions
- Statistical programs should be on an annual or multi-annual basis by governments in African countries to improve quality of official statistics
- Statistical business processes should be transparent and follow international standards of good practice.
  - National statistics offices in African Countries should provide a way to judge the performance of the statistical system.
